

**Planning Committee**

**July 14, 2016**

## Administration

1. Mr. Steve Herling, PJM, called the meeting to order and asked if the Planning Committee had any additional items for the agenda. There were no suggestions for additional agenda items.
2. Mr. Herling asked Ms. Bridgid Cummings to review the meeting minutes of the June 9, 2016 Planning Committee meeting. Mr. Herling asked the Planning Committee to approve the minutes. Mr. Dave Pratzon made a motion to approve the minutes. Mr. Barry Trayers seconded the motion. In a voice vote, the Planning Committee approved the June 9<sup>th</sup> Planning Committee Minutes.

## Endorsements/Approvals

### 3. **PJM Manual 20 Updates**

Mr. Tom Falin, PJM, presented updates to PJM Manual 20, which are a result of a periodic review of this manual. Revisions included updating out of date language to ensure the manual reflects current processes, as well as revisions needed to clarify the implementation of Capacity Performance. Mr. Dave Pratzon made a motion to endorse and Mr. Carl Johnson seconded the motion. **In a voice vote, the Planning Committee endorsed the changes regarding updates to Manual 20.**

### 4. **Load Model Selection**

Mr. Falin, PJM, presented the load model selection for the 2016 RRS (Reserve Requirement Study). The selected model is the 10 year (2003-2012, #51002) load model including a shift in World peak week for the 2016 RRS Base Case. Mr. Dave Pratzon made a motion to endorse and Mr. Carl Johnson seconded the motion. **In a voice vote, the Planning Committee endorsed the load model selection.**

## Informational Updates

### 5. **Transmission Owner Upgrades**

Mr. Mark Sims, PJM, provided an update regarding the Operating Agreement section on Transmission Substation Equipment. This is being addressed in conjunction with the FERC Order 206 compliance filing (Docket ER-16376). The committee will be provided with updates as they come available.

### 6. **PJM/NYISO Wheel Modeling**

Mr. Sims, PJM, provided education about the ConEd Wheel as well as provided an update on the operation and planning protocols related to the cancellation of the ConEd Wheel. Mr. Sims also discussed the potential cost allocation impacts as well as the Transmission Planning assumptions related to the cancellation.

## 7. Network Upgrade Cost Allocation

Mr. Aaron Berner, PJM, presented a problem statement regarding New Service Request Cost Allocation. He discussed the key work activities to be addressed in Special Planning Committee sessions. The expected deliverables are Tariff and Manual language to define the new cost allocation requirements or a discussion to be presented to the Planning Committee for the reason why the current cost allocation rules should be maintained in their current form.

## 8. Queue Processing of Small Generation Resources/Upgrade Requests/Transmission Service Requests

Mr. Berner, PJM, presented a problem statement regarding New Service Request Study Methods. He discussed the key work activities to be addressed in Special Planning Committee sessions. The expected deliverables are Tariff and Manual language to define the new cost allocation requirements or a discussion to be presented to the Planning Committee for the reason why the current cost allocation rules should be maintained in their current form.

## 9. PJM Manual 7 Updates

Mr. Mark Kuras provided an update on the history of Appendix F, Triggered Fault Current Limiters, in PJM Manual 7 as well as a clarification that the Appendix is being moved from the Manual to the Protective Relaying Philosophy Document.

## 10. NERC/RRO Update

Mr. Kuras, PJM, provided an update on recent NERC activities and PJM compliance activities. NERC standards subject to future enforcement can be found under the July 14<sup>th</sup> Planning Committee Material at the [Planning Committee Website](#).

## 11. PPL New Line Designation

Mr. Mike Donnelly, PECO, presented revisions to the PECO transmission planning criteria.

## Informational Section

### PJM/MISO Queue Study Coordination & Retirement Studies

On June 20, 2016, in Docket No. EL13-88-000, PJM Interconnection, L.L.C. ("PJM") and Midcontinent Independent System Operator, Inc.; (1) jointly submitted their informational filing to provide a status report to the Commission in compliance with the April 21, 2016 Order on Complaint and Technical Conference regarding their progress on developing generator retirement study coordination processes, and (2) submitted proposed revisions to the Joint Operating Agreement entered into between PJM and

MISO, Article IX, sections 9.3 to include a single set of agreed-upon interconnection coordination procedures that are currently in the PJM and MISO business practice manuals.

## Order 1000 Lessons Learned

On April 29, 2016, an Order 1000 Lessons Learned meeting was held. PJM presented a path forward which included 3 tracks: Reliability project process document, Energy Efficiency project process document, and TEAC Redesign. A fourth track was suggested at the meeting: Upgrade projects. PJM is working on drafts of the process documents and discussing ideas for TEAC Redesign internally. Additional meetings will be scheduled.

## Subcommittee/Task Force Updates

### DEDSTF

The DEDSTF last met on 6/15/2016. At that meeting the three sub groups (Substations, lines and protection) continued discussions on the organization/development of the Design Standards as well as the process of reviewing the existing materials. The next meeting of the DEDSTF is 7/19/2016.

### Transmission Replacement Processes Senior Task Force (TRPSTF)

As of the most recent TRPSTF meeting on June 20th, all of the education sessions have been completed. At the meeting on June 3rd, several modules were covered, including duties, rights, and obligations of signatories to the CTOA along with a review of Order 888, Order 890, Order 1000, and the Atlantic City decision. Additional topics included FERC rules and orders surrounding planning process and transparency, and cost recovery and allocation. The fourth and final education session was held on June 20th. PSEG discussed the additional value and benefits brought to the overall system from the inclusion of supplemental upgrades. AEP presented on their Asset Health Center which focuses on condition, performance, and risk assessment drivers over a simple assessment of asset age. AEP also shared class/voltage asset ages. Additional Orders (679, 889, 2000, and 2003) were also reviewed the most recent education session. At the next meeting on July 18th, the group will proceed with formal interest identification and commencement of the CBIR process.
