## Administration

1. Mr. Paul McGlynn, PJM, called the meeting to order and reviewed the Code of Conduct and Anti-Trust. Mr. Mark Sims reviewed the upcoming Siemens trainings being offered at PJM's Campus, details are available via this link: <http://www.pjm.com/~media/committees-groups/committees/pc/20170608/20170608-informational-pjm-siemens-training.ashx>.
2. Mr. McGlynn asked Ms. Bridgid Cummings to review the meeting minutes of the May 4, 2017 Planning Committee meeting. Mr. McGlynn asked the Planning Committee to approve the minutes. Mr. Dave Pratzon made a motion to approve the minutes. Mr. Barry Trayers seconded the motion. In a voice vote, the Planning Committee approved the May 4, 2017 Planning Committee Minutes.

## Endorsements

### 3. PJM Manual 14F

Mr. Michael Herman, PJM, reviewed the proposed draft of Manual 14F: PJM Competitive Planning Process Manual. He noted that the consideration of cost cap/containment provisions for competitive proposals will continue to be discussed at Special PC Sessions, the next being held on July 18, 2017. Mr. John Kopinski made a motion to endorse and Mr. David Scarpignato seconded the motion. There were no objections and two abstentions. **In a voice vote, the Planning Committee endorsed the new Manual 14F.**

### 4. Designated Entity Design Standards Task Force

Mr. Herman, PJM, presented a summary of the compilation of the documents written as part of the efforts of the Designated Entity Design Standards Task Force. These requirements developed by the DEDSTF will be applicable to all proposals that require the signing of a Designated Entity Agreement (DEA). Mr. Barry Trayers made a motion to endorse and Mr. Dave Pratzon seconded the motion. There was one objection and one abstention. **In a voice vote, the Planning Committee endorsed the Designated Entity Design Standards.**

### 5. PJM Manual 14C

Ms. Suzanne Glatz, PJM, presented updates to Manual 14C: Generation and Transmission Interconnection Facility Construction. The updates are to align the manual language with the work being completed through the Designated Entity Design Standards Task Force. Mr. Dave Pratzon made a motion to endorse and Mr. Alex Stern seconded the motion, there were no objections and one abstention. **In a voice vote, the Planning Committee endorsed the updates to Manual 14C.**

## 6. IRM Study Assumptions Letter

Mr. Jason Quevada, PJM, presented the assumptions for the 2017 Reserve Requirement Study (RRS) to establish the initial Installed Reserve Margin and Forecast Pool Requirement for the 2012/2022 Delivery Year. Mr. Carl Johnson made a motion to endorse and Mr. Barry Trayers seconded the motion, there were no objections and no abstentions. **In a voice vote, the Planning Committee endorsed the IRM Study Assumptions Letter.**

## 7. PJM Manual 20

Mr. Patricio Rocha-Garrido, PJM, presented redline changes to Manual 20: PJM Resource Adequacy Analysis. The redline changes are specific to language describing Zonal and Global Locational Deliverability Areas for CETO calculations. Mr. Ronnie Bailey made a motion to endorse and Mr. Carl Johnson seconded the motion, there were no objections and no abstentions. **In a voice vote, the Planning Committee endorsed the updates to Manual 20.**

## 8. Load Model Selection

Mr. Rocha-Garrido, PJM, presented the results of the Load Model selection process for the 2017 Reserve Requirement Study. The committee will be asked to endorse the Load Model selection at its next meeting.

## 9. PJM M14B and PJM Operating Agreement Updates – TEAC Redesign

Ms. Amanda Long, PJM, presented updates to PJM Manual 14B (PJM Regional Transmission Process) and the PJM Operating Agreement in regards to the RTEP cycle timeline and the proposal window duration. The updates relate to updating the proposal window from 30 days to 60 days. The committee will be asked to endorse these updates at its next meeting.

## 10. PJM Manual 14A

Mr. Joe Hay, PJM, presented an overview of the upcoming redline changes to Manual 14A (Generation and Transmission Interconnection Process). These updates were identified as part of the biennial review of the manual. Redline changes will be brought for review at the July Planning Committee meeting.

## 11. Light Load Analysis Methodology

Mr. Mark Sims, PJM, provided an overview of the Light Load Analysis methodology and discussed the potential of modifying the test assumptions and parameters to reflect current operations and recent historical data. This will be brought back to the Planning Committee for further discussion.

## 12. Grid Resilience in System Planning

Mr. Sims, PJM, provided an introduction to grid resilience in Transmission Planning. There was a discussion pertaining to Grid Resilience in Transmission Planning and this will continue to be brought back to the Planning Committee for further discussion.

## 13. CETL Calculation Discussion

Mr. Sims, PJM, lead a discussion pertaining to the CETL Calculation Methodology. The discussion included a detailed description of how firm and non-firm transfers are modeled currently and in the future. ### Winter Season Resource Adequacy and Capacity Requirements

The Resource Adequacy Analysis Subcommittee reviewed further analysis results related to the Winter Season Resource Adequacy and Capacity Requirements Problem Statement. The analysis examined the following items for the RTO and for selected LDAs: winter forced outage distributions, actual winter

planned outages vs. PRISM winter planned outages and winter generator maintenance. This discussion will continue at the July 6th RAAS meeting.

## Order 1000 Projects and Cost Capping/Cost Commitment Special PC Meeting

On May 24, PJM conducted a Special PC meeting to begin discussion of the Cost Capping/Cost Commitment. The topic of the first meeting was focused on fundamental concepts of cost capping forms that have been observed by PJM and within the industry. The materials included a general overview of rate based revenue recovery fundamentals and Net Present Value calculations of hypothetical projects for different forms of cost capping. The next meetings are scheduled for July 18 and August 21. Additional meetings will be scheduled as necessary.

Per MOD-032-1 Requirement 2, PJM is requesting that Generator Owners please submit existing generation data into GenModel on the Planning Center website by June 15th. Generators at unit level that are at least 20 MW or have CIRs or generation facilities that have at least 75 MVA at the plant level should submit data. <http://planningcenter.pjm.com/genmodel>
