Administration (1:00-1:05)

- A. Mr. Anders announced the following new member companies approved for PJM membership since the last meeting, bringing the total membership to 1044:

 - Trishe Wind Ohio, LLC (Affiliate Member) selected the Generation Owner sector
 - Walleye Energy, LLC (Affiliate Member) selected the Generation Owner sector
 - Whitney Hill Wind Power, LLC (Voting Member) selected the Generation Owner sector

Mr. Anders noted that one member had withdrawn since the last meeting.

- B. Mr. Anders confirmed the presence of a quorum.
- C. Mr. Anders reminded participants of Antitrust and Code of Conduct requirements.

Consent Agenda (1:05-1:10)

Items A and B were **approved** by acclamation with no objections or abstentions.

- A. Draft minutes of the May 16, 2018 meeting
- B. Proposed revisions to the confidentiality provisions of the Operating Agreement (OA) to specify that PJM may share member confidential information with reliability entities in addition to NERC
- C. Proposed OA, Tariff and RAA revisions to clean-up governing agreement cross-references
- D. Proposed OA and Tariff revisions regarding the Long Term FTR Auction issue

Endorsements/Approvals (1:10-2:40)

1. Planning Committee Cost Containment Proposals (1:10-2:10)

- A. Mr. Andy Ott, PJM President and CEO, discussed transmission related issues.
- B. Ms. Janell Fabiano discussed proposed OA revisions related to Order 1000 competitive transmission project cost containment provisions.

Mr. James Davis proposed a friendly amendment to add the following to the proposed OA revisions:

PJM may not alter the requirements for proposal submission to require the submission of a binding cost containment proposal, in whole or in part, or otherwise mandate or unilaterally alter the terms of any such proposal or the requirements for proposal submission, the submission of any such proposals at all times remaining voluntary.

There were no objections to this being considered friendly and therefore it was incorporated into the main motion.

Mr. Chip Richardson raised a point of order seeking confirmation that the voting on the proposed OA revision was in order because OA section 18.6 requires that the PJM Board of Managers receives the proposed OA revisions, and is afforded the opportunity to provide comments, and further that Members are only authorized to vote upon consideration of the Board's comments. Mr. Chris O'Hara opined that OA section 18.6 does not create a legal basis to delay a vote on the proposed revision to the OA of the sort under consideration; rather it is the view of PJM that section 18.6 of the OA, when read in its entirety, pertains to OA revisions related to PJM governance and, further, creates a right of the Board to provide comments on such matters. Mr. O'Hara also referred to the course of dealing and long history of voting on proposed OA revisions relating to non-governance matters without invocation of this provision. Separately, Mr. O'Hara noted that the membership should recognize that (i) three PJM Board members were in fact in attendance at the meeting, (ii) one Board member (Andy Ott) had in fact provided comments, and (iii) that the Board had engaged on the topic of cost containment in general (not on the specific proposed revision) and provided comments to PJM. Mr. O'Hara stated that this course of dealing suggests that OA section 18.6 should be read in accordance with Manual 34: Stakeholder Process sections 15.5 and 15.6 that provide for communication with the Board through the posting of stakeholder materials.

Mr. Mike Borgatti, Members Committee (MC) Chair, ruled on the point of order based on PJM's legal opinion that a vote would be allowed to be taken. He also noted that three members of the PJM Board were in attendance at the meeting and that Mr. Ott had provided comments.

Mr. Robert O'Connell moved and Ms. Adrien Ford seconded a motion to challenge the decision of the Chair. Following discussion the motion to sustain the decision of the Chair was **approved** in a sector weighted vote with 4.5 in favor.

Following discussion, the proposed revisions were **approved** in a sector weighted vote with 4.28 in favor.

- A. Mr. Mike Borgatti provided an update on the Members Committee Annual Plan. Mr. Anders noted that PJM was developing suggestions for how to stage the work on some stakeholder process

issues, and that in coordination with the MC Chair and Vice Chair will bring those suggestions to the MC at the July 2018 MC Webinar and MC meeting for consideration.

- B. Mr. Mike Borgatti provided a report on the May 15, 2018 General Session and plans for the August 1, 2018 Liaison Committee meeting with the PJM Board of Managers. Mr. Borgatti noted the announced August 2, 2018 Kleinman Center activity related to the PJM stakeholder process, and also discussed the planned PJM stakeholder effort to identify any areas for stakeholder for enhancement of the PJM stakeholder process.
