1. Administration

Ms. Lisa Morelli called the meeting to order and welcomed stakeholders. Ms. Morelli reviewed the agenda and called attention to the Anti-trust and Code of Conduct statements. Ms. Cheryl Mae Velasco performed roll call and reviewed the draft meeting minutes from the 4/28 ERPIV meeting. The minutes were approved.

2. Review of MRC Approved Proposal

Ms. Morelli reviewed the alternate motion that was approved at the May 29 MRC. The original PJM package did not pass and an alternate motion was brought forward. The alternate motion was comprised of the original PJM proposal with an additional statement requiring the short term solution to sunset on September 30, 2014. In addition, PJM would need to file a long term solution with FERC by October 1, 2014. The long term solution should be implemented as soon as technically feasible with a desired target of January 1, 2015.

3. Review Workplan

Ms. Morelli reviewed the draft workplan. With the approval of the alternate motion, the group will have an accelerated schedule in order to present packages to the September MIC and MRC/MC. No requests for changes were made.

4. Interest Identification

Ms. Morelli reviewed the Interest Identification tab of the matrix as it currently stands. One additional interest was included regarding timely reporting of events in the summer when increasing reserves was implemented.

5. <u>Energy/Reserve Pricing Matrix Review</u>

Ms. Morelli reviewed the Long Term options tab of the matrix as it currently stands. A request for any additional education was made.
