1. Administration

Concerns surrounding the voting timeline were brought up and it was mentioned that regardless of when the voting would take place, the solutions would not be able to be implemented until after the winter 2015 period. Several stakeholders expressed concern with this timeline and requested that the solution in place for the winter will need to be established.
