



Overview





Contributing factors to posting delays

Reason	Impact	Overall Assessment
Primary - Overlapping Periods	High	Overlapping periods cause the optimization engine to run longer which increase case run time
Other - Bid Volume	Medium	Higher bid counts increase case run time
Other - Outages	Medium	Higher number of outages taken create more constrained cases which increase case run time
Other - Options	Medium	Allowing option bids and calculating option prices increase case run time
Other - Hardware	Low	New production application servers are put in service every two to three years
Other - Software	Low	Currently investigating software improvements with our vendor












Annual FTR Auctions










Monthly FTR Auctions Two Period Overlap Cases






Monthly FTR Auctions Three Period Overlap Cases






Monthly FTR Auctions Four Period (Super) Overlap Cases
