## Administration

1. Ms. Christina Stotesbury, PJM, provided announcements and reviewed the Antitrust, Code of Conduct, and Public Meetings/Media Participation Guidelines.
2. The committee approved the draft minutes from the August 9, 2017 Market Implementation Committee meeting by acclamation with 0 objections and 0 abstentions.
3. A. Ms. Christina Stotesbury, PJM, reviewed the active MIC issues on [Issue Tracking](#).  
B. Mr. Thomas Zadlo, PJM, provided a brief update on the release of Data Miner 2.  
C. Mr. Jeff Schmitt, PJM, notified stakeholders the deadline to submit Fuel Cost Policies for Intraday Offers was September 15, 2017. All currently approved Fuel Cost Policies expire on November 1, 2017, and as part of the Annual Review Process, require updated policies to specify the resource's Intraday Offers election, and must be approved no later than November 1, 2017.

Market Sellers that plan to participate in the Offer Verification Exercise are required to have their unit cost data entered in COA by October 1, for the exercise scheduled on October 5. Registration for the Offer Verification Exercise is posted on the [Tech Change Forum](#). All Market Sellers are required to have the resource cost data in COA by November 1 to be eligible for make-whole greater than \$1,000/MWh.

## Endorsements/Approvals

4. **Manual 11 Revisions for Intraday Offers**
  - A. Ms. Lisa Morelli, PJM, reviewed conforming revisions to Manual 11: Energy & Ancillary Services, associated with the implementation of Intraday Offers. **The committee endorsed the manual revisions with 99 in favor (72%), 38 opposed (28%), and 21 abstentions.**
  - B. Ms. Lisa Morelli, PJM, presented a first read of Operating Agreement and Manual 11 revisions to amend the offer capping logic resulting from the PJM/IMM discussions at the August MIC meeting. The committee will be asked to endorse the manual revisions at the October MIC meeting.
5. **Annual Revenue Requirements for new Black Start Units – Phase 2**

Mr. Tom Hauske, PJM, reviewed the PJM & IMM proposal to address Minimum Tank Suction Levels (MTSL) as part of Phase 2 for the Annual Revenue Requirements for new Black Start units. **The Committee did not endorse the proposed solution with 71 opposed (52%), 66 in favor (48%), and 26 abstentions.**

## 6. Manual 6 Revisions for FTR Forfeiture revisions

Mr. Brian Chmielewski, PJM, reviewed Manual 6: Financial Transmission Rights revisions associated with FTR Forfeitures. **The committee endorsed the Manual 6 revisions with 114 in favor (82%), 25 opposed (18%) and 35 abstentions.**

## 7. Manual 28 Revisions for Intraday Offers

Mr. Ray Fernandez, PJM, reviewed Manual 28: Operating Agreement Accounting revisions associated with the implementation of Intraday Offers. **The committee endorsed the Manual 28 revisions by acclamation with 0 objections and 0 abstentions.**
