Administration

1. Ms. Bhavana Keshavamurthy and Ms. Chantal Hendrzak provided announcements; reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation, the WebEx Participant Identification Requirement.

2. Fuel Cost Policy- Problem Statement & Issue Charge

Mr. John Rohrbach, ACES Power, on behalf of SMECO, ODEC and PPGI, presented a problem statement and issue charge to address enhancements to the Fuel Cost Policy rules and process. **The committee approved the problem statement and issue charge with 0 objections and 0 abstentions.**

3. RPM Credit Requirement Reduction Clarifications

Mr. Hal Loomis, PJM, presented draft Tariff language to remove an apparent overlapping credit reduction provision for Qualified Transmission Upgrades, to clarify milestone documentation requirements for internally financed projects, and to clarify that Capacity Market Sellers should submit requests for reductions.

The committee endorsed the Tariff changes with 0 objections and 0 abstentions.

The committee also preferred this package over status quo with 0 objections and 0 abstentions.

4. Transmission Constraint Penalty Factor

Mr. Angelo Marcino, PJM, reviewed the joint PJM/IMM package developed at the Special MIC sessions related to Transmission Constraint Penalty Factors, and present draft Manual 11 language.

The committee endorsed the M11 changes with 0 objections and 4 abstentions.

The committee also preferred this package over status quo with 1 objection and 2 abstentions.
