Administration

Bhavana Keshavamurthy reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the June 3, 2020 Market Implementation Committee meeting by acclamation with **0 objections and 0 abstentions**.

1. Bhavana Keshavamurthy reviewed the MIC Work Plan.
2. Dave Anders announced the distribution of a poll regarding the ARR FTR Market Task Force. The poll results will be reviewed at the August MIC meeting.
3. Ms. Morelli announced that this meeting is Bhavana Keshavamurthy's last meeting as MIC secretary and thanked her for contributions to the committee over the past two years. Nick DiSciullo will assume the role of MIC secretary starting in August.

Endorsements/Approvals

2. Subcommittee Consolidation

Scott Baker proposed the sunset of the Intermittent Resources Subcommittee (IRS) and reviewed the charter for the Distributed and Inverter-based Resources Subcommittee (DIRS).

The committee approved the sunset of the IRS by acclamation with 0 objections and 0 abstentions.

The committee approved the DIRS charter by acclamation with 0 objections and 0 abstentions.

3. PRD Credits Disposition

Sharon Midgley, Exelon, provided an overview of the Problem Statement and Issue Charge addressing the Price Responsive Demand (PRD) Credits Disposition.

The committee approved the issue charge by acclamation with 0 objections and 0 abstentions.

4. Transparency in Performance Assessment Interval Settlements

Susan Kenney reviewed the problem statement and issue charge addressing additional transparency in settlement calculations for non-performance charge.

Some stakeholders expressed concern with the redline language that was included in the version of the issue charge. In particular, they noted that the language referencing the ability to rerun the October 2, 2019 Performance Assessment Interval settlements as needed was unnecessary as

PJM has this ability absent any language in an issue charge. PJM agreed to strike the redline language prior to voting. PJM acknowledged that the removal of that language does not prevent PJM from being able to rerun the settlements if their regulatory oversight process identifies that any of the Oct. 2, 2019 calculations were not done in compliance with the Tariff following the stakeholder discussions on this issue charge.

The committee decided to send the education on this topic to MIC Special Sessions. Conversation on this topic will resume at the regularly scheduled MIC meetings after the conclusion of education.

The committee approved the issue charge with the redline language removed by acclamation with 1 objection and 0 abstentions.

5. **Manual 14D and Manual 27 revisions**

Ray Fernandez reviewed updates to Manual 14D: Generator Operational Requirements and Manual 27: Open Access Transmission Tariff Accounting related to changes to deadlines for adjustments associated with finalizing the zonal network service peak load values. Stakeholders raised concerns regarding the date change in Manual 14D and the impacts to units coming into service in November. Stakeholders requested an additional month to work with PJM offline to address these concerns.

The committee deferred the endorsement vote for the Manual 27 revisions to the August MIC meeting.

Working Item

6. **Stability Limits in Markets and Operations**

- A. Ray Fernandez provided education on the rules for compensating units for lost opportunity costs.
- B. Catherine Tyler, Monitoring Analytics, provided the IMM's perspective on the issues with the status quo for stability limited units and the proposed capacity constraint package. Stakeholders requested that PJM look into performing an analysis to determine lost opportunity/uplift costs that would have been paid to stability limited units.
- C. Lisa Morelli led a discussion on the matrix.

Additional Items

7. **Capacity Capability Senior Task Force Update**

Andrew Levitt discussed work being done at the Capacity Capability Senior Task Force under the Market and Reliability Committee regarding Effective Load Carrying Capability.

8. **MOPR Subsidy Guidance**

Alexandra Salaneck, Monitoring Analytics and Paul Scheidecker provided an overview of the MOPR subsidy process to provide guidance to participants as to which programs constitute a state subsidy. Stakeholders requested an update on the guidance process to address the plan for identifying whether individual state default service auctions meet the definition of a state subsidy or not.

9. **Forward Looking Energy & Ancillary Services Offset Methodology**

Gary Helm provided an update on the development of the forward-looking E&AS Offset methodology.
 Additional MIC Special Sessions have been scheduled for July 21 and July 30 to continue discussion on PJM's proposal on the forward-looking E&AS Offset in advance of the August 5 compliance filing.
