



## DER and Inverter-based Resources Subcommittee (DIRS) Solar-Battery Hybrid Resources - Final Report (Phase I)

July 1, 2021

### Issue Creation

The Solar-Battery Hybrid Resources [Problem Statement](#) and [Issue Charge](#) was brought forward by PJM staff and approved by the members at the June 3, 2020 Markets Implementation Committee [meeting](#).

### Issue Summary

From the key work activities of the issue charge, the DIRS worked to provide education on solar-battery hybrid resources, including the current interconnection and planning analyses related to this resource type, the electrical configurations of hybrid and co-located solar-battery hybrids, as well as any other existing PJM business rules that apply to this resource type. The subcommittee then discussed potential gaps in business rules and improvements that could be made to address the integration of this emerging class of resources in the PJM market.

### Consensus-Based Issue Resolution Process

Number of Meetings and date range covering this topic: The DIRS met 12 times from August 2020 to June 2021 to discuss this issue.

### 1. Package A

Package A provides updates to PJM’s governing documents and business manuals to clarify various aspects of market participation by solar-battery hybrid resources.

First, the proposal introduces new definitions and modifies existing definitions. “Mixed Technology Facility”, “Hybrid Resource”, “Co-located Resource”, and “Open-Loop Hybrid Resource” are newly defined terms. “Open-Loop Hybrid Resource” also gets added to the existing Energy Storage Resource definition. And finally, “Standalone Energy Storage Resource” is defined to draw distinction between Hybrid Resources and all other Energy Storage Resources. These definitions are required to clarify new resource types, draw distinction between different forms of hybrid resources, and apply new or existing business rules to each resource type.

For Co-located Resources, the proposal clarifies that market participation occurs separately for each underlying resource type. Metering and telemetry are required both at the Point of Interconnection (POI) and on one or all of



the underlying resource types behind the POI, depending on the telemetry point (MW, MVAR, state of charge, meteorological data).

For Hybrid Resources and Open-Loop Hybrid Resources, the proposal introduces participation models for solar-battery hybrids that will be similar to the existing ESR Participation Model (Order 841), except that a “solar-only mode” will be added to the ESR model, non-energy Regulation & reserves modes would be removed, and for closed-loop solar battery hybrids the ESR model lack negative MW offer parameters since these resources are physically incapable of charging from the grid.

The proposal also clarifies that solar-battery hybrid resources should report both eDART and GADS outages separately for the solar component and storage component whenever unavailable or derated. No eDART ticket is required for lack of solar irradiance, charging, nor lack of charge.

And finally, the proposal provides new reactive testing requirements for both AC-coupled and DC-coupled hybrid resources.

## 2. Package C

Package C is identical to Package A except for one solution option in design component #5 pertaining to the Regulation Market. Package A proposes to measure Regulation performance at the POI of the hybrid resource. Package C proposes:

“For hybrid resources, two ways to provide regulation service are available:

(1) Battery output is used to balance out intermittent renewable output, where resource response is measured at the point of interconnection meter.

(2) Battery output is not used to balance out intermittent renewable output, and resource response is instead measured independently for the battery component level using submeter output/telemetry.”
