Administration

Nicholas DiSciullo reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the December 1, 2021 Market Implementation Committee meeting with **0 objections and 0 abstentions**.

Stephen Bennett, PJM, provided an update on the status of Pennsylvania's participation in the Regional Greenhouse Gas Initiative (RGGI) as it relates to the offers of Pennsylvania generators in the energy market.

1. **Weak Encryption Retirement**

Amanda Egan provided an update on the retirement of Weak Encryption and its impact to the Voting Application.

2. **FERC Order on Voluntary Remand (Reserve Price Formation)**

PJM provided an overview of the FERC's December 22, 2021 order on voluntary remand (Reserve Price Formation – dockets EL19-58-006, ER19-1486-003) and next steps for the required compliance filings. The discussion included an overview of the draft capacity market base residual auction (BRA) schedule, treatment of the Energy & Ancillary Services offset for the upcoming BRA and application of offer capping in the reserve market.

Endorsements/Approvals

3. **De-Energized Bus Replacement**

Vijay Shah reviewed revisions to Manual 11: Energy and Ancillary Services Market Operations as part of 5 Minute Dispatch and Pricing. The changes address enhancements to the Dead Bus Replacement logic for assigning prices to de-energized pricing nodes.

The committee endorsed the Manual 11 revisions by acclamation with 0 objections and 0 abstentions.

4. **Capacity Offer Opportunities for Generation with Co-Located Load**

Jason Barker, Exelon, reviewed a problem statement and issue charge addressing the treatment of generation with co-located load. Revisions were made to the Key Work Activities and Scope section of the Issue Charge during the meeting to address federal and state jurisdictional bounds impacting co-located load configurations and the potential impact of co-located load configurations on generator capacity capability. A "Post-Meeting" version of the Issue Charge has been posted to the meeting materials.

The committee approved the revised Issue Charge with 207 (92%) in favor, 17 (8%) opposed, and 29 abstentions.

5. **Pseudo Modeled Combined Cycle Minimum Run Time Guidance**

Tom Hauske reviewed education and a Problem Statement and Issue Charge addressing Pseudo Modeled Combined Cycle Minimum Run Time Guidance. **The committee approved the Issue Charge by acclamation as part of the “CBIR Lite” process outlined in Section 8.6.2 of Manual 34 with 0 objections and 0 abstentions.**

Upon Issue Charge approval, the committee began interest identification and work on the Consensus Based Issue Resolution matrix. PJM provided draft design components, options and a solution package to jump start the discussion in this CBIR Lite process. Additional design components and solution options can be provided in advance of the next meeting. If no additional design components or solution options are provided in advance of nor during its next meeting, the discussion at the January committee meeting will be treated as a first read of the proposal and the committee will be asked to vote on the proposal at its next meeting.
