Administration

Nicholas DiSciullo reviewed the Antitrust, Code of Conduct, Public Meetings/Media Participation and the WebEx Participant Identification Requirements.

The Committee approved the draft minutes from the June 8, 2022 Market Implementation Committee with **0 objections and 0 abstentions**.

1. Zeenath Fernandes provided an update on the retirement of Weak Encryption and its impact to Markets applications.

Endorsements/Approvals

2. Variable Environmental Costs and Credits

- a) Melissa Piong reviewed a proposal providing detailed guidance and updates to rules related to variable environmental charges and/or credits and their inclusion in cost-based energy offers.
- b) Joel Luna, IMM, provided education on the inclusion of Renewable Energy Certificates (RECs) and Production Tax Credits (PTCs) in cost-based offers.

The committee endorsed the proposal with 180 (82%) in favor, 39 (18%) opposed, and 5 abstentions. A second vote showed stakeholders preferred the proposal over the status quo with 178 (85%) in favor, 32 (15%) opposed, and 21 abstentions.

3. Market Suspension

- a) Stefan Starkov reviewed the PJM/IMM Package addressing the treatment of long-term market suspensions.
- b) Sean Chang, Shell, provided details on a friendly amendment to the PJM/IMM Package to allow for the short-term suspension to use DA LMPs, if available, for suspensions lasting between 6 and 24 hours. The friendly amendment was accepted by PJM and the IMM, and the post-meeting version of the Matrix has been posted to the meeting materials.

The committee endorsed the Revised PJM/IMM Package by acclamation with 0 objections and 0 abstentions, including revisions to the original short-term solution endorsed by the MIC and to the longer-term proposal over the original solution endorsed by the MIC.

4. Manual 6 Revisions

5. Manual 18 Revisions: Hybrid Resources

Andrew Levitt provided an update on the recent hybrids filing (Docket No. ER22-1420) and reviewed conforming revisions to Manual 18: PJM Capacity Market.

The committee endorsed the Manual 18 revisions by acclamation with 0 objections and 15 abstentions.

b) Ilyana Dropkin provided a first read of conforming revisions to Manual 15: Cost Development Guidelines to address the Reserve Price Formation implementation, and a first read of Biennial revisions to Manual 15.

The committee will be asked to endorse the conforming Reserve Price Formation and Biennial Manual 15 revisions at its next meeting.
