2. Manual 11 Periodic Review (9:15 – 9:35)

Joey Tutino reviewed revisions to Manual 11: Energy & Ancillary Services Market Operations as part of the periodic review. An amendment was made to remove substantive revisions to Section 2.3.4.4 on Real-time Values for additional review.

The committee endorsed the amended revisions by acclamation with 0 objections and 0 abstentions.

Performance Impact of Multi-schedule Model in MCE on ECC Model Implementation (9:35 – 10:20)
Keyur Patel reviewed a revised Joint PJM/IMM Issue Charge to address the performance impact of
a multi-schedule model in the Market Clearing Engine (MCE) of the Enhanced Combined Cycle
(ECC) and Energy Storage Resource (ESR) models as part of the Next Generation Energy
Markets (nGEM) project.

The committee approved the Issue Charge with 80.5% in favor and 19.5% opposed. Work will begin in MIC Special Sessions.

4. Periodic Review of Default CONE and ACR Values (10:20 – 10:45)

Skyler Marzewski reviewed background information and proposed changes to the Default CONE and ACR Values discussed in the MIC Special Sessions.

The committee voted in support of the proposed changes by acclamation with 0 objections and 0 abstentions. This vote was advisory, and proposed Tariff revisions will be presented at the March 22, 2023 Markets and Reliability Committee (MRC).

Unless otherwise noted, PJM stakeholder meetings are open to the public and to members of the media. Members of the media are asked to announce their attendance at all PJM stakeholder meetings at the beginning of the meeting or at the point they join a meeting already in progress. Members of the Media are reminded that speakers at PJM meetings cannot be quoted without explicit permission from the speaker. PJM Members are reminded that "detailed transcriptional meeting notes" and white board notes from "brainstorming sessions" shall not be disseminated. Stakeholders are also not allowed to create audio, video or online recordings of PJM meetings. PJM may create audio, video or online recordings of stakeholder meetings for internal and training purposes, and your participation at such meetings indicates your consent to the same.

#### Participant Identification in Webex:

When logging into the Webex desktop client, please enter your real first and last name as well as a valid email address. Be sure to select the "call me" option. PJM support staff continuously monitors Webex connections during stakeholder meetings. Anonymous users or those using false usernames or emails will be dropped from the teleconference.

#### Participant Use of Webex Chat:

The use of the Webex chat feature during meetings shall be primarily reserved for administrative and logistical purposes, such as managing a question or comment queue, noting technical difficulties, and meeting support or management purposes. Utilizing Webex chat for any other commentary should be limited to short phrases. Detailed commentary or substantive dialog shall be shared orally by entering the speaker queue.
