Changes associated with PJM's CIFP ER24-99 Filing

- PJM's CIFP Filing (ER24-99) - all changes are to become effective with the 2025/2026 Delivery Year
- PJM Manual changes will be implemented in two rounds
 - The first round of PJM Manual changes will be focused on those that are applicable to the conduct of the 2025/2026 BRA (e.g. changes associated with planning parameters and resource accreditation, etc.)
 - The second round will be those changes that are to be implemented for the actual 2025/2026 Delivery Year (e.g., changes to seasonal capability test requirements and shortfall charges, new seasonal generator operational testing requirements, etc.)
