#### **ADMINISTRATION**

Mr. Kormos welcomed stakeholders to the meeting and Mr. Anders provided the Anti-trust and Code of Conduct announcements.

Mr. Boston Discussed the status of the PJM Board of Managers review of the Capacity Performance initiative, indicating that the Board will continue to consider action at its upcoming meeting December 1-3, 2014.

Ms. Luna discussed pending updates to PJM's website.

#### **ENDORSEMENTS/APPROVALS**

#### 1. DRAFT MINUTES

Minutes of the October 30, 2014 Markets and Reliability Committee (MRC) meeting were <u>approved</u> by acclamation with no objections or abstentions.

#### 2. PJM MANUALS

- A. Ms. Reiter presented proposed revisions to Manual 3: Transmission Operations.
- B. Mr. Pilong presented proposed revisions to Manual 13: Emergency Operations.
- C. Ms. Horowitz presented proposed revisions to Manual 11: Energy & Ancillary Services Market Operations related to Overlapping Ancillary Service and Load Management Events.
- D. Mr. Sims presented proposed revisions to Manual 14B: PJM Regional Transmission Planning Process related to PRC-023-3 and TPL-001-4.
- E. Mr. Fernandez presented proposed Manual 28: Operating Agreement Accounting revisions to include Load Reconciliation data in the settlement of Emergency Load Response and Emergency Energy Billing.
- F. Ms. Daugherty presented proposed revisions to Manual 29: Billing regarding treatment of underpayments of miscellaneous items or special adjustments.
- G. Mr. Hsia provided a 2015 DASR update including proposed revisions to Manual 13: Emergency Operations.

Following discussion, the proposed revisions in items 2.A through 2.G were **endorsed** by acclamation with no objections or abstentions.

# 3. <u>ENERGY / RESERVE PRICING & INTERCHANGE VOLATILITY (ERPIV) UPDATE</u>

Ms. Morelli discussed the work of the ERPIV special sessions of the Market Implementation Committee (MIC) regarding updating the interchange volatility proposal. She presented an updated proposal developed by the group. Following discussion, the committee **endorsed** the updated proposal by acclamation with five objections and two abstentions.

#### 4. GAS UNIT COMMITMENT

Ms. Hendrzak presented a proposal developed in special sessions for the Operating Committee regarding Gas Unit Commitment. Following discussion, the committee **endorsed** the proposal by acclamation with no objections and one abstention.

# 5. <u>SELLER CREDIT</u>



Ms. Daugherty presented a proposal to remove Seller Credit, a form of unsecured credit, from the credit policy. Following discussion, the committee **endorsed** the proposal by acclamation with no objections and one abstention.

# 6. RESIDENTIAL DEMAND RESPONSE: PARTICIPATION IN THE PJM SYNCHRONIZED RESERVE MARKET & MEASUREMENT AND VERIFICATION FOR ENERGY AND LOAD MANAGEMENT

Ms. Shira Horowitz presented proposals developed by the Demand Response Subcommittee related to Residential Demand Response. Following discussion, the committee **endorsed** the proposals in a sector-weighted vote with 4.03 in favor.

#### 7. DEFINITIONS IN GOVERNING DOCUMENTS

Following discussion, the committee **endorsed** the proposed Revisions by acclamation with no objections or abstentions.
