1. Rebecca Carroll, PJM, called the meeting to order. Ashwini Bhat, PJM, reviewed the Antitrust, Code of Conduct, media participation, WebEx and In-person meeting participation guidelines.
2. Rebecca Carroll reviewed and stakeholders approved the February 06, 2023 Planning Committee (PC) Agenda.

Gizella Mali, PJM, reviewed Version 18 of the TO/TOP Matrix as part of the periodic review. **The draft TO/TOP Matrix V18 was approved by acclamation with 0 objections and 0 abstentions.**

5. FPR and IRM Update

Josh Bruno, PJM, provided a first read of the Updated Forecast Pool Requirement (FPR) and Installed Reserve Margin (IRM) for 2025/26. **The updated FPR and IRM were endorsed by the committee upon first read with 87(57.2%) in favor, 65 (42.8%) opposed and 89 abstentions.**

Revised Issue Charge has been posted to January and February PC section on PJM.com. **The committee will be asked to approve the Issue Charge and endorse the Manual revisions as part of the Quick Fix process outlined in Section 8.6.1 of Manual 34 at the March PC meeting.**
