## 1. ADMINISTRATION

The Subcommittee approved the minutes of the September 16, 2014 meeting by acclamation with no objections and no abstentions.

### 2. BLI TRANSFER TOOL UPDATE

Hal Loomis gave an update on the status of the BLI transfer tool which is expected to go into production the middle of January 2015.

### 3. VIRTUAL TRANSACTIONS POLAR VORTEX IMPACT

Stephanie Staska of Twin Cities Power made a presentation on the company's proposal for changing the Jan-Feb 2015 INC/DEC credit requirements. PJM presented a zonal analysis of the Twin Cities proposal. The Members decided to not recommend modifications to the credit policy for INC/DEC transactions for Jan-Feb 2015 based on the



Issue Charge submitted by Twin Cities Power and approved by the MIC at the September MIC meeting. Twenty members expressed support for the proposal, 49 expressed opposition, and twelve abstained.

#### 4. PMA CREDIT REQUIREMENTS MATRIX

Mr. Loomis led a discussion on the component packages matrix of potential change to the Peak Market Activity (PMA) credit requirements. Narmada Nanjundan of East Kentucky Power Cooperative made a presentation on EKPC's proposal for changing the PMA calculation. For help in designing the proposal packages that stakeholders will ultimately offer at the October 29 CS meeting, it was decided that PJM would conduct an online poll prior to that meeting to measure stakeholder interest in options that have been expressed for individual components of the proposals.

#### 5. FUTURE AGENDA ITEMS

Updates to the FTR credit requirement analysis and the INC/DEC credit requirement analysis will be added to the agenda for the October 29 CS meeting.
