

**DER and Inverter-based Resources Subcommittee – EDC Coordination workshop on DER

Administration (10:00 - 10:05)

1. Scott Baker opened the meeting and reviewed the agenda.
2. Hamad Ahmed reviewed the meeting participation guidelines.

Order 2222 – Distribution Company Coordination (10:05 – 11:55)

3. Danielle Croop provided a brief overview of Order 2222, PJM's compliance timeline, and reviewed in more detail the RTO and distribution company coordination directives in the Order.
 - Danielle discussed FERC order no. 2222, DER and DER aggregators along with opt-in provisions. Danielle reviewed 10 key compliance directives highlighting directive no. 8; Address coordination between the RTO/ISO, the DER aggregator, the distribution utility, and the relevant electric retail regulatory authorities ("RERRA") (278).
 - Danielle also reviewed high level overview of the FERC order no. 2222 stakeholder process timeline highlighting Q4 2020 for education on the order. Danielle indicated that PJM plans on developing a straw proposal during Q1 2021 and work through stakeholder feedback on the straw proposal with recommendations and iteration during Q2 2021. Finally, PJM plans on drafting and submission of the compliance filing in Q3 2021. The compliance filing is due July 19, 2021.
4. Scott Baker solicited feedback from distribution companies on their perspectives regarding the Order, and the specific coordination directives.
 - The group heard from a number of distribution companies including PPL, First Energy, Pepco, Duquesne, PSEG, and Dominion. DER aggregators Enel X and CPower also provided comments.
 - There were a number of requests to hold additional workshops on the EDC and DER Aggregator coordination issues. PJM agreed to look into scheduling more of these workshops.
 - Some distribution companies raised concerns about doubling counting, safety of the distribution grid and the 60-day EDC review process described in the FERC Order.
5. PJM Staff reviewed an initial framework for distribution company coordination and solicited input and feedback from stakeholders.
 - Madalyn Beban reviewed FERC order no. 2222 operational requirements and reviewed possible initial requirements from PJM. Madalyn opened the floor for an open discussion format to gather feedback on EDC needs.

- Pete Langbein reviewed DR EDC review process and FERC order no. 2222 consideration. Pete discussed DR and EDC definitions with some background on EDC’s role in the DR participation process. Pete reviewed the DR process status quo and the EDC status quo role during the DR registration process. Pete also discussed potential impacts by RERRA restrictions on the wholesale market participation by DR and additional EDC coordination based on FERC order no. 2222.
