Administration (9:00 – 9:20)

1. Scott Baker, PJM, opened the meeting and reviewed the agenda.
2. Hamad Ahmed, PJM, reviewed the meeting participation guidelines. The minutes from the last DIRS meeting and the EDC coordination workshop were approved with 0 objections and 0 abstentions.
3. Scott reviewed the DIRS work plan.
 - Scott reviewed the DIRS work plan discussing key milestones around Order 2222 highlighting that April's DIRS would focus mainly on straw proposal discussion.

Order 2222 – Discussion on straw proposal (9:20 – 2:30)

4. PJM Staff continued to review a straw proposal for DER Aggregation that sought to address the various compliance directives in Order 2222. The straw proposal is meant to provide a more holistic view of how PJM staff is initially approaching each topic area, and to serve as a starting place for further collaboration between staff and stakeholders on PJM's compliance filing.
 - Danielle Croop, PJM, started the discussion with an update on the extension request and briefly reviewed the extension timeline. Danielle also discussed min/max size requirements highlighting that no minimum size requirements will be defined and that PJM is considering a max size of 5 MW for individual DERs, meaning DER greater than 5MW will not be eligible to participate in a DERA. Stakeholders discussed this proposal, including comments around the rationale for PJM's proposal, comments to increase this value to 10MW consistent with thresholds elsewhere in the PJM Tariff, and others around local utility requirements determining the max size threshold rather than PJM.
 - Edward Rich III, PJM, discussed meter data requirements and several topics within settlements such as DR participation, day ahead, balancing, operating reserves, DERA settlements and Demand Response. Ed also discussed several settlements examples for DER, DERA and DERA with deviations and double counting.
 - Danielle discussed several use case options and welcome proposals from stakeholders on how different DERA use cases can participate in wholesale markets and be metered.
 - Pete Langbein, PJM, discussed EDC coordination process highlighting key steps such as DER registration and utility review. Pete reviewed key EDC responsibilities for FERC Order 2222 and registration review timeline.

- Pete reviewed ‘modification of list of resources’ language within Order 2222 and noted that this was an area that PJM still needed to develop further with stakeholder input on that process.
- Michelle Farhat, PJM, reviewed Operations coordination for day ahead run, after day ahead run and re-bid and intraday, status quo and distribution override. Michelle stated that PJM will need to define communication and data requirements to ensure proper settlements addressing both retail and wholesale billing.

5. Daniel Moscovitz, PJM, provided education on pricing nodes and how they relate to PJM’s proposed aggregation model.

- Daniel discussed PJM markets calculations for Enodes and Pnodes and emphasized that DER aggregators will need to work with EDC/utility to understand electrical locations of DER. Daniel also reviewed an example for different DER’s nodal aggregation.

Solar-Battery Hybrid Resources (2:30 – 2:55)

6. Skyler Marzewski, PJM, provided updated clarification on the application of the Minimum Offer Price Rule for co-located and hybrid resources.

- Skyler reviewed PJM process calculating MOPR prices for Solar plus battery, hybrid resources and co-located resources and discussed MOPR qualification for co-located and hybrid units. Skyler also discussed MOPR decision tree for Solar plus Battery.

7. Stakeholders reviewed progress on the solar-battery hybrid solutions matrix and discussed next steps towards recommending a proposal to the MIC (and OC).

- Andrew Levitt, PJM, discussed a new design component; resource classification process and edits to package A for regulation and resource classification process.
- Connie Lowe, Dominion, reviewed an additional solution option and commented that Dominion may seek to propose an additional solution package at the May DIRS meeting.
