Administration (10:00 – 10:10)

1. Scott Baker opened the meeting and reviewed the agenda.
2. Hamad Ahmed reviewed the meeting participation guidelines. The minutes from the EDC coordination workshop in October and November and the DIRS in October were approved with zero objections and zero abstentions.

Order 2222 – Staff input on compliance proposal (10:10 – 12:00)


3. Discussion on the functional roles of “Market Agent” and “Dispatch Agent” in the DERA operational coordination model.
 - a. Donnie Bielak, PJM, provided additional thoughts on how these roles will be implemented by reviewing the proposed operation coordination model. Donnie emphasized that PJM does not intend to define ‘Market Agent’ and ‘Dispatch Agent’ in the Tariff as part of the compliance filing and reviewed several other thoughts on the implementation of roles.
 - b. Bruce Campbell, CPower, provided input on the role of the Dispatch Agent highlighting that CPower supports a properly designed dispatch agent (DA) construct.
4. Thomas DeVita, PJM, discussed proposed Tariff language around categories of DER registration data.
5. Madelyn Beban, PJM, reviewed updates to use cases based on stakeholder feedback.
 - a. Maddie discussed use case updates, high-level overview of outline for use cases, homogeneity vs heterogeneity in different DERA levels and walked through use case 1, 2 and 3.

Order 2222 – Stakeholder feedback on compliance proposal (12:30 – 2:45)

6. Danielle Croop, PJM, will reviewed a small number of changes made to the compliance proposal since the last meeting.
 - a. Danielle reviewed DER terminology on slide 9 that will be implemented into the PJM Tariff, proposed data requirements for Planning on slide 20, annual verification of DER aggregation modeling on slide 21, registration data on slide 134 and Market Participation agreements on slide 25
7. Danielle reviewed current thinking on implementation timing for the DERA Market Participation Model and took stakeholder comments on this implementation timing. Danielle stated that expected implementation date is 2025/2026 or earlier, if feasible.

Action items (2:45 – 3:00)

8. The facilitation team reviewed action items from the meeting and took requests for future agenda items.
 - a. PJM team to bring location data exchange process between Pnode and planning model bus and use case examples to EDC coordination workshop on December 9, 2021.
 - b. PJM stakeholders requested more detail on the implementation date and net metering.
 - c. There was a request to add to the parking lot a future deliverable that outlines which functional entities need to be a member, and which do not, with respect to the entire DERA participation model.
