Administration

PJM reviewed the Anti-Trust Policy, Code of Conduct, Public Meetings/Media Participation Policy and performed roll call. The Subcommittee approved the minutes from the December 13, 2022 MSS meeting. Informational items for 2023 Settlement C tracking were also reviewed.

Working Issues

1. Winter Storm Elliott PAI Billing details

- A. Sean Flamm, PJM, reviewed updates to the non-performance assessment MSRS reports in relation to the Winter Storm Elliott performance assessment intervals. Additional columns were detailed to be added from business rule changes to market areas since the reports were originally created.
- B. Natasha Holter, PJM, gave an overview of how non-performance assessment billing would appear on PJM monthly billing statements and provided details around PJM's planned monthly bonus holdback from initial billing. Examples for the monthly bonus holdback were provided in an additionally posted Excel document. Natasha also gave a reminder about the PAI billing election screen in the BLIT tool that was active from February 22, 2023 to March 17, 2023. *NOTE* The item 1_b presentation material was updated after the meeting to correct a typo on slides 7-9 describing the amount of interest in the extended PAI billing examples.

2. Updates to Schedule 9 and 10 Load Reconciliation for Schedule 9-PSI updates

Nick DiSciullo, PJM, reviewed planned updates to the Schedule 9 and 10 Load Reconciliation Charges report to capture additional columns related to the Schedule 9-PSI updates and to remove deprecated columns from prior to the Schedule 9 rate updates that occurred in January 2022.
