Credit Study in FTR Center

- The Credit Study Market in FTR Center was developed to allow Participants with a way to quantify their FTR Credit Requirements with their existing portfolio and additional bids prior to the Credit screen
- Submitting bids for a Credit Study is done similarly to submitting a bid in a Market- however, you will need to submit the bids to the Market that ends with "Credit Study"
- Please note that these submissions to the Credit Study Market are NOT officially submitted bids. In order for the bids to be considered for the Auction you MUST submit them to the official Market.
